

# Krav Maga Israel

This document is only a summary and does not replace the required bylaws and registration forms, which every student of Krav Maga Israel is required to sign and act on, the documents are available for reference on the Krav Maga Israel website.

#### General

The various courses of Krav Maga Israel (according to the procedures of the parent company Shalom College LLC USA) allow individual study or a group of frontal and online courses in a variety of subjects, according to the courses that the students have in enrolled in and are seeking to complete their training through us. Upon successful completion of the course trainees will be awarded a diploma on behalf of Krav Maga Israel.

The opening of the course is conditional on arranging a full payment with the tuition section, each registrant must sign all forms, including the registration forms and medical release form, which is bound by all the conditions specified therein, and the interpretation will only be entitled to Krav Maga Israel.

# Before the training / instruction starts: Procedure for cancellation of studies and refunds

A registrant who has completed the registration process and who has not yet begun his or her training who wishes to quit or postpone his studies will notify Krav Maga Israel's offices, sign an application form and will be charged tuition in accordance with the conditions specified in the study regulations that he or she signed.

No cancellations will be accepted and no funds will be refunded after starting any training!

## The method of learning in certain courses is both frontal and online:

- The beginning of courses in a predetermined order and according to a syllabus that is to be taken from the registration section.
- Progress to the next course is conditional upon passing a grade in the current course.
- In each course there are independent studies of the study material.
- If necessary get help from the pedagogical department / Krav Maga Israel instructor via email / phone / at a meeting at the Krav Maga Israel facility through prior arrangement.



- After completing the course and proving proficiency in the material, an online test (multiple choice test) must be taken on the material being studied which must be passed with the required grade according to the course to which the student is enrolled.
- Each online test will be allowed 2 deadlines, which the student must pass with the required grade, all 2 additional deadlines will be charged in accordance with the Krav Maga Israel's (300 NIS) policy.
- Passing the online test allows trainees to move on to the next online course

## Culminating test - completion of studies and obtaining a final certificate

- Upon successful completion of the examinations in all frontal and online courses, the student must coordinate a final test with the offices of Krav Maga Israel.
- For each final examination, 2 deadlines will be allowed, in which the student must pass the required grade (according to the track), all 2 additional deadlines will be charged in accordance with Krav Maga Israel 's policy (NIS 300).
- The weighted final score consists of 80% of the frontal test scores and 20% of the online test score.

#### Eligibility and receiving a final certificate

Trainees who have completed their studies, have met all their obligations and successfully passed all the tests will be eligible for a diploma according to the course they have completed. The certificate will be given in the offices of Krav Maga Israel after signing forms in accordance with the procedures of Krav Maga Israel.

## **Examinations and grades (re-examination costs)**

A. The passing grade for a theoretical examination in courses in the continuation studies to a higher level is 70+. In addition, the student must check with the institution the admission conditions for advancement to a higher level, it is mandatory for every student to take the examinations on the first iteration. Failure on the first iteration will be eligible for the second iteration. Any additional deadline involves payment subject to regulations.

B. In exceptional cases, such as: illness, military reserve duty, joyous event or family mourning, with as a result the student will not be able to take the examination (deadline 1 and / or 2), the student may test again at a special time at no additional charge.

C. Retests 3 and 4 can be repeated at a cost of NIS 300, the 5<sup>th</sup> retest will cost 25% of the course's cost. If the trainee fails this test there will be a 6 month freeze on training and payment for taking the course again will incur a 25% re-enrollment fee. Also work will be submitted work according to the pedagogical manager / coach's guidelines.



D. It is compulsory for every student who has completed their studies to take a concluding test in Krav Maga Israel's office / facilities or wherever required. Scheduling must be done in advance.

#### The integrity of examinations

Krav Maga Israel sees the integrity of examinations as a fundamental and important element of the curriculum, which is conditional upon receiving a diploma and grade report on Krav Maga Israel's behalf. The integrity of the examinations exists and the proper management of examinations is an educational, valuable and moral task, with which the whole system is called to prepare for in order so that this will be completely successful.

At the frontal and online examinations the students who are tested are asked to show their full academic ability and achievements in subjects that have been examined at Krav Maga Israel(franchisees), utilizing their personal and frontal physical capabilities in a test that is intended to evaluate the integrity of their achievement and the proof of achievement has arrived directly from without direct supervision of the management, to allow the examinees fair and uniform examination conditions.

## Responsibility of the examinee

- A. Obey all regulations and guidelines pertaining to the integrity of examinations.
- B. Maintain the integrity of the examinations, and this responsibility is personal and absolute, and is not dependent or contingent upon the obligations. The examinee alone shall be responsible if he or she violates the examination rules and does not maintain the integrity of the examinations.
- C. Comply with all examination conditions to answer the examination's questions without the aid of others or helping others and without using or using unauthorized material for that specific examination.

# The responsibility of Krav Maga Israel to maintain the integrity of the examinations will be expressed as follows:

- A. Providing information to students and teachers about examination practices and the duty to maintain the examination's integrity.
- B. Disseminating the content of the regulations to maintain the integrity of the examinations among students.
- C. Conduct examinations while maintaining the integrity of the examinations and enforcing the rules.
- D. Providing instructions to the test supervisors before the examination and monitoring what is done at the examination.

## The behavior of the examinee



- A. The examinee is required to strictly and accurately follow all digital instructions on the screen, as well as to follow instructions given to him or her orally or in writing before or during the examination, by the supervisors. Failure to follow the instructions may result in the test being disqualified.
- B. The examinee must only work on his or her own. He or she must not help another examinee or others or assist another examinee or others in any form, such as talking and forwarding or receiving notes and possession of books, notes and the additional auxiliary measures, other than those allowed for use in the particular test that he or she was examined on or was notified of before the examination.
- C. Examinees cannot bring in any item (equipment, vitamins, medication, written, recorded, etc.) or any device (radio, portable cassette player, calculator, cellphone, cordless phone, etc.) that was not expressly designated as "permitted auxiliary aids". It is desirable that such material should not be brought at all on the day of the examination. If such material is nevertheless brought by the examiner, it will be placed behind the supervisor's table until the examination is over. The presence of such material in the examining authority at the time of the test will invalidate the test.
- D. The examinee will not be allowed to leave the examination room, even if he or she has completed his or her examination or decided to quit, before a half an hour has passed after the examination begins. If the examinee leaves the examination room, despite the supervisor's warning, this can result in the test being disqualified, and the examination integrity committee would consider additional disciplinary steps against the examinee.

## **Procedural disciplinary measures**

- A. The Krav Maga Israel Office will take one or more of the following disciplinary steps against an examinee found guilty of violating examination integrity guidelines or violating one or more of the examination procedure's instructions:
- B. Disqualifying the examination and suspending the eligibility for a certificate and a score sheet until a re-examination in the same course (the possibility of eliminating this course from the composition of the qualifying examinations will not be possible, even if the disqualified course is an excess elective, beyond the composition required for eligibility for the certificate and the grade sheet).
- C. Suspending the possibility of retesting for a set number of deadlines, up to a year.
- D. Suspension of the examinee from examinations in all the subjects he or she has left for a period of up to one year.
- E. Cancel all or part of the examinations in which the examinee was able to take.



F. Suspension or expulsion of the student immediately from his or her studies at Krav Maga Israel for all that implies.

• It should be noted that all examination integrity procedures and the institution's procedures apply to every student who is enrolled, this is conditional on signing the registration form, regulations and a release letter in which the trainee confirms that he or she understands the examination integrity procedures.

A release letter for the entire course and in relation to the training in which I will participate in or participate in in the future I give my consent and confirm to Krav Maga Israel that I take on all risks of injury or damage that may be caused to me or my property during the activities described above and I accept on my behalf and on behalf of my heirs that in no case shall a complaint or claim be filed against the Krav Maga Israel or Shalom Dror, or any of its officers, agents and counsel for damages or claims for damages or damages caused to me or my property as a direct or indirect result of my participation or attendance during training ( my participation in the course), and I also agree on my behalf and on my heirs' behalf and on behalf of my executors or my estate's executives to exempt from any liability Krav Maga Israel or Shalom Dror, or its officers, its messengers and employees, and its instructors and all, and undertake to indemnify Krav Maga Israel, or Shalom Dror, or any of the foregoing due to a lawsuit filed against them.

I acknowledge and accept all the natural hazards involved in martial arts training that I document with Krav Maga Israel with Shalom Dror, or its officers, its messengers, and all.

I acknowledge and agree to participate in martial arts course activities that include physical fitness, various exercises including sparring and other tests that involve my participation in the course.

I declare that I have read and understood the foregoing disclaimer, and I also know that once I have signed this disclaimer, I will not be able to renege it.

Note: The decision to cancel the course with Krav Maga Israel is only at the student's decision and this summary he or she signed is of his or her own free will - any responsibility for it only applies to him or her!
