

# Regulations

Introduction: The courses taught by Krav Maga Israel are courses for knowledge and certificate studies only!

Note that Krav Maga Israel is a representative and service provider of Shalom College LLC, which has professional, scientific and theoretical knowledge as well as technology for online study of the entire field).

- A. Every student in Krav Maga Israel has a duty to read, understand the rules and make a commitment by signing the regulations.
- B. In this regulation, the procedures, rights and obligations of the students in Krav Maga Israel are described.
- C. Registration for Krav Maga Israel's courses constitutes the candidate's consent to follow the bylaws and commit to their compliance.
- D. These terms and conditions have been approved by the Krav Maga Israel / KMI and are authorized to change it from time to time.

# Student status

- A. A full-fledged student is a learner who has gone through the admissions stages, given all the required credentials and who paid all tuition.
- B. A student who fails to comply with all the requirements of the bylaws will not be certified and will not receive a certificate.
- C. A student who wishes to quit his / her studies will notify Krav Maga Israel in writing. In this case, the student will be entitled to receive a certificate on the studies he has studied, tested on and graded.
- D. The studies and tests at Krav Maga Israel take place in Hebrew / English only.
- E. The registration fee of NIS 350 is not returned at all except in case of failure to open the course initiated by the institution.
- G. The full payment for the course is required prior to commencement of studies, otherwise the student's studies will be frozen until disqualification from continuing, with no refund of the payment paid.
- H. Signing of these policies is valid from the time of signing and throughout the course, including multi-year courses.
- I. This procedure is valid even if the student's studies were interrupted by Krav Maga Israel.

B. Tuition will be paid in the following ways:		

Credit card payment.

Payment by cash or bank transfer.

**Note:** Tuition fees can be paid \* up to 3 interest-free payments or \* up to 6 interest-rate payments at 5% starting with the first payment or \* up to 10 interest-rate payments at 10% starting from the first payment.

### **Terms of Registration**

All persons who register for Krav Maga Israel's activities have a duty to read and understand the rules, and commit by signing to agree to the regulations and the use of Krav Maga Israel's facilities and any other activity is the sole responsibility of the student.

- 1. The Krav Maga Israel will not be liable for any damage and / or loss of property and / or theft of property for any reason in the area of the facility.
- 2. The student undertakes to adhere to the safety instructions and rules of use of Krav Maga Israel's facilities.
- 3. Commits to obeying the instructions of the instructors and therapists in the various facilities and under no circumstances without prior guidance.
- 4. Krav Maga Israel reserves the right to immediately discontinue the studies of a student who does not comply with any of the above instructions, rules and regulations and / or in any way interferes with the proper operation of Krav Maga Israel and / or causes damage to Krav Maga Israel's property.
- 5. Period of activity. : The activity period will be from \_\_\_ / \_\_\_\_ to \_\_\_ / \_\_\_\_ .
- 6. Studies should not be frozen, except by prior arrangement, and for a justified reason, determined and approved by the management and head.

Cancellation of payment for Krav Maga Israel will be deemed as non-compliance with Krav Maga Israel 's regulations, and will result in immediate cessation of membership, without prejudice and other measures that Krav Maga Israel is entitled to.

### Regulations and procedure for termination of studies

A. A student who has completed the formal registration process at Krav Maga Israel, including payment, is a student for all intents and purposes.



B. However, there are exceptional personal circumstances that prevent the student from committing to commence his or her studies at the beginning of the course or the academic year in which he / she enrolls, in which cases the student may be canceled by giving written notice in accordance with the termination notice procedure. Krav Maga Israel needs to be authorize the notice through its agreement. Also, officially the student needs to come to the office and sign an internal form.

C. We note that the student must verify that his or her message has been received. A phone message will not count as a notice of ceasing of studies.

D. A student who announces the termination of his / her studies will be charged tuition in accordance with the following conditions: (see table below).

Note: This applies except when the student decided to stop due to personal or health reasons					

**Insurance**: Medical insurance will only apply to the student and all responsibility for this is with the insurance companies, including the responsibility for payment for medical services that the student receives from any entity.

**Cleaning and maintaining the equipment**: Students are required to maintain the cleanliness of the classrooms and halls and the integrity of the equipment inside them, do not eat or drink in classrooms, such behavior constitutes a disciplinary offense.

**Updating details**: Any change in the student's personal information requires the student to update the secretariat of the institution.



# The student must comply with all of Krav Maga Israel's requirements, with emphasis on:

- Filing signed registration forms with photo ID, signature of the regulations, registration form, explanation of course options, medical form, athlete insurance coverage covering martial arts / self-defense, release/waiver of claim against the institution in case of injury or injury of any kind, indemnity form in case of a claim for a suit against the student.
- The student needs to update Krav Maga Israel regarding his or her criminal history.
